As at 30 June 2011, the net asset value ('NAV') of Reinet Fund S.C.A., F.I.S. amounted to € 2 997.2 million, an increase of € 210.9 million from 31 March 2011.

This valuation reflects the Fund's holding of 84 303 670 shares in British American Tobacco p.l.c., its other investments, cash resources, other assets and liabilities. The assets and liabilities have been revalued to their fair values as at 30 June 2011. The NAV calculation has not been audited.

The entire ordinary share capital of the Fund is owned by Reinet Investments S.C.A. In addition, 1 000 management shares in the Fund are held by Reinet Fund Manager S.A.

The net asset position of the Fund is a substantial element of the consolidated balance sheet of Reinet Investments S.C.A. at 30 June 2011. However, the consolidated balance sheet of Reinet Investments S.C.A. will reflect other parent company assets and liabilities, including amounts payable to or receivable from the Fund. As such, the net asset value of Reinet Investments S.C.A. may differ from that of the Fund.
